What the Office currently does/how it operates (Current State):

- Embrace high standards of ethics, management and accountability—Multifamily Housing demands that its partners manage their properties at national standards of financial and physical condition, including providing only appropriate subsidy when available, and continue to meet such standards in all of their business relationships with HUD.
- Promote participation of faith-based and community organizations—Multifamily Housing reaches out and encourages the participation of faith-based and community organizations in HUD's programs for the elderly and for persons with disabilities, creating effective partnerships with such organizations in communities throughout the United States.
